General Business

Calendar dates - spoke about COC district and National events. John asked if we have two seperate events. Anneka said the new event graded champs will replace the old one. District event could still be qualifier event so clubs send a team of their best in each grade and winners go through to nationals.

Anneka asked if the district events will alternate between MWR and Taranaki and should we be letting clubs know that to qualify they need to be from particular part of district? John advised the only event that tends to jump back and forth between zones is District COC. Junior one dayers selected 3.3.23 Eastern

Wellington Junior One dayer to be decided for date in May.

Jeff asked when JP sponsorship is up Pauline said it goes for 2 years. Expired in 30th August needs to be renewed. Ginny said a lot of the kids are motivated by the prizes. John asked if we should try and negotiate a spot prize per tournament. John offered to negotiate this when he see Geoff next. Jeff said he thinks they are getting good name recognition for what they are putting in.

Cindy said Oliver is quite active within their club and its definitely worth talking to Prince. Jeff asked John to renegotiate and Pauline to see him the contract.

Cindy asked if the JP should be split into the two zones? And then have them come together for the finals that would keep the travel down. Jeff said do we split it into 3 regions even? Often we have two on the same date thats at different ends of the region. Would this mean the kids are playing the same people over and over. John said there are a few that do a lot of travelling and they end up ahead a lot of the time as they get points for every entry. John said it used to be the best 5 results counting.

Pauline said will this cut down numbers even more? A lot of families found it hard. John said some Ohakune players went to a Taranaki JP and there were only half a dozen players there so they were a bit put off.

Ginny said the club has to be involved and have a Junior programme. Pauline said the clubs have to have something for Juniors to expect them to show up and play. The clubs need to be encouraging schools and running Junior programmes. Cindy said there is no one to run the programmes. Anneka said maybe we need to support the clubs more with the coaches. The clubs that have a good Junior programme have some key people to run the programmes. Jeff said some parents use the Juniors as a baby sitting service.

Anneka said what can we do, we can't be at the clubs delivering the programme so what can we do to support the clubs with this.

Events review committee have done nothing yet so have nothing to report.

TSB funding for Taranaki area - clubs want coaching. Finding the person that can do coaching and when suits the clubs to do it. Jeff See moved that we apply for funding for coaching. Jeff asked Amy if she can put together something. Amy said where do I get all the information from about who does the coaching or any of that information. Jeff asked how would we put forward. Pauline said you need a coaching plan and a coach. Jeff said for Amy to ask Tamsyn but Amy advised she doesn't think she is very keen to do much and that Luke Jones is an option and he is keen. Jeff said he will leave it to Amy, John said maybe there should be a coaching co ordinator to bring juniors into the clubs. Amy said would be good to get into the schools around here. John asked about the micro courts, 1 is at Bretts place. Anneka said there were walls with SNZ, Pauline advised they were rubbish to play on after having a go at COC Nationals.

Ginny asked about Paul Hornsby camps she has been talking to Paul and has 3 dates locked in. Ginny asked if its just for Juniors or seniors etc.

Jeff said we would be more inclined to get him in March, Ginny said he wants to do preseason techniques. The camp was about \$2000 for the weekend. John said it seems excessive and who gets to go to it. Ginny said it was the Nationals teams this year he had a limit of about 12/13 players. Our coaches get \$200 a day.

PW said can we pencil him in and if we don't get the grant we will cancel it.

Kent Darlington has emailed interest and wants to come on board to assist, would be good to get coaches booked so we can be on to it for next season. Jeff said its great to have Ginny onboard and you have made a great positive difference and made the role your own and make sure you will be back next year which will be great.

Brett - Fletch has contacted Feilding to see if he can use the club for a coaching course late November.

Pauline said we have not had a coaching facilitator for number of years and it should be a role that must be filled. We are a long way behind the other districts as far as coaching opportunities on offer goes. There are certain roles on the committee that should be left empty if we can't find a volunteer we should be paying to have it done.

John - Maybe we should be asking what he has on offer for next year. The foundation coaching is ideal for getting all the juniors going and when he does offer it, the results are great. John said we can probably do 3 - 4 of them spread around the district and encourage some coaches.

Amy - On the Treasurers report there was 2 amounts on there that were reimbursements for Inter - club. PC said it was for MWR interclub reimbursement. Amy asked why do we have it on our books instead of them having their own. PW said they do have their own account but we have control of it. Amy asks why we have on our ledger. PW advised its not that straight forward MWR zone was not able to get internet baking access set up so the district manages the account for them and deposits half the interclub fees into it for them to spend as they like.

Discussed the senior role and if we have anyone in mind for this going forward. It would be good to have the input in this role from the planning meeting. Anneka said she doubts Melville will be putting his hand up for the role again.

Discussed planning meeting dates, decided on 3rd December.

Pauline said for those that can't attend to get any planning through to be presented.
